

Defensible Space Inspections

Captain DeDeo led the inspection program to bring all properties into compliance with the State and County's defensible space requirements, with the help of all the FD staff. OVFD worked with Placer County to utilize the Hazardous Vegetation Ordinance MOU, ultimately OVFD was not able to hand over any properties to Placer County for compliance or abatement. This required additional inspections and contacts with property owners. As of November first, only a few properties are out of compliance, and all have been contacted and agreed to have the work done this fall. Most of these properties were/are at the mercy of the contractor's availability to schedule and complete the work.

Fuels Management Program

District staff continue to coordinate with Deer Creek Resources and Wildland Rx on the Olympic Valley Community Wildfire Protection Plan (CWPP). Staff also met with Feather River Forestry (Danielle Bradfield) about upcoming grants, and opportunities for the District to work with the USFS on the Five Creek Project. Danielle is also helping identify programs which may be beneficial for the Firewise Community to pursue. Staff is working to develop staffing and budget program scenarios and a critical timeline for a potential parcel tax measure.




