- D-2 Operations Enterprise Fund: Mr. Campbell said the statement for the current fiscal year shows 50% of the year has elapsed and expenditures without depreciation are running at 43.5% of the annualized budget, or 6.5% favorable.
- D-3 Fire Government Fund: Mr. Campbell said the Fire statement for the current fiscal year shows 50% of the year has elapsed and expenditures without depreciation are running at 50.1% of the annualized budget, or .1% unfavorable.
- D-4 Fund Balance Sheet: Mr. Campbell reviewed the fund balance sheet.
- D-5 Capital Reserve Balance Sheet: Mr. Campbell reviewed the fund balances with the Committee. Mr. Campbell provided a Consolidated Revenues & Expenditures, Consolidated Balance Sheet, and Consolidated Statement of Cash Flow reports. These reports are for internal use only as financial tracking tools, and Mr. Campbell said he is hesitant to publish and distribute this report at this time

because it may mislead the public. Mr. Geary said he would like to meet with Mr. Campbell next week to discuss this issue.

Mr. Geary provided a review of the item which is a request to authorize early termination of the lease of District facilities at 1810 Squaw Valley Road. Director Sheehan asked how much rent money we would be losing. Mr. Campbell replied approximately \$8,000.

G-3 Administration Report:

Mr. Campbell reviewed the report including information for the bike trail snow removal project. Through the end of December, the District has incurred \$29,028.76 in snow removal expenses, of which \$34,913.51 has been billed to the various community sponsors, with \$20,424.92 being paid as of the date of this report.

Director Sheehan said at staff's request he reviewed the last seven months of credit card statements and everything was in order. He will continue this practice on a random basis.
