- D-3 Fire Government Fund: Ms. L'Heureux said the statement for the current fiscal year shows 16.6% of the year has elapsed and expenditures without depreciation are running at 20.1 % of the annualized budget or 3.3% unfavorable. Chief Bansen reviewed the anticipated wild fire reimbursement revenues.
- D-4 Fund Balance Statement: Ms. L'Heureux reviewed the fund balances. The highest rate is Placer County at 1.210%.
- D-5 Capital Reserves: Ms. L'Heureux reviewed the fund balances with the Committee.
