SUBJECT: Olympic Meadow Property – Disclosure of Potential Conflict of Interest

BACKGROUND: Thomas S. Archer, District Counsel, has been advising Squaw Valley Public Service District ("District") and the Truckee Donner Land Trust ("Land Trust") regarding the offer for purchase of the Poulsen Family property, located at 325 Squaw Valley Rd., Olympic Valley and represents the interest of Eric J. Poulsen in his capacity as a Director of the District. As such, there is, at least, an appearance of a conflict of interested and/or the potential that an actual conflict of interest may arise in the future.

DISCUSSION: If the District would like Mr. Archer's continued advice relating to this important acquisition, Mr. Archer requests the District and Land Trust execute an acknowledgement that the District acknowledges and understands the Disclosure of Conflict of Interest and waives the same.

ALTERNATIVES: 1. Authorize the General Manager to execute the Acknowledgement of Disclosure of Potential Conflict of Interest.

2. Do not authorize the General Manager to execute the Acknowledgement of Disclosure of Potential Conflict of Interest.
