A. Call to Order, Roll Call and Pledge of Allegiance. President Dale Cox called the meeting to order at 8:45 A.M.

Public Comment -

Brad Chisholm commented on the tragic events in Orlando, FL and as emergency responders the Fire Department staff is aware and concerned about these situations.

Brad Chisholm requested that the public be notified when the Board reconvenes in open session in general and after today's closed session discussion. He offered suggestions to improve communication amongst staff and the Board including the Fire Department hosting a barbeque to become better acquainted. He also commented on the Fire Department's labor negotiations and the importance of having more Board involvement.

Mr. Archer said he is present during closed session and no agreements are made during this time nor are any matters discussed which are not on the closed session agenda. Any action may only be taken during open session. Unfortunately there is no way of knowing how long a closed session may last.

Director Hudson said he supports communication with staff especially as the valley is a small and tight-knit community. He said the Directors are charged with providing general direction and policy making, rather than being involved in daily management of District operations.

President Cox said labor negotiations make communication amongst staff and the Board very sensitive and during labor negotiations communication must be handled very carefully.

Brad Chisholm said many of the Fire Department staff voted in favor of the labor contract although they do not believe it is a good agreement. They voted out of fear and would not have supported the agreement if they did not feel intimidated by management.

Mr. Geary said he supports the idea of improving communication with the Board as suggested by Mr. Chisholm but would have liked to have heard him include all of the District departments, not just the Fire Department.

Directors Wilcox/Poulsen made a motion to adjourn the open session and reconvene in closed session; vote was unanimous.
